Safeguards Rule?

FTC Extends Deadline for “Reasonable Cyber Safeguards”

The FTC Safeguards Rule requires many companies to implement reasonable cyber safeguards. This includes creating an *information security program* and implementing some mandatory cyber security technologies. The deadline of December 9, 2022 has now been pushed back to June 9, 2023. The rule applies to a wide variety of non-banking financial institutions. If you handle sensitive non-public customer data, your firm might be required to comply. 2022 Cybersecurity Trends: Rackspace blames ransomware attack for ongoing Exchange outage

Cloud computing giant Rackspace has confirmed that it has been hit by a ransomware attack that has left a number of its customers without access to email.

Rackspace’s hosted Microsoft Exchange service started experiencing problems on Friday last week. At the time, Rackspace posted a notice on its status page saying that due to a “security incident,” it had “powered down and disconnected” the service. In an update published on Tuesday, Rackspace has confirmed that a ransomware attack is behind the ongoing outage.
